- You have your own login and password is simple to re-set.
- We ask questions and request documents from your personal checklist.
- You answer our questions and can ask your own questions as well.
- Smartphone compatible for uploading images.
- Your access is always available, and it does not expire.
- If you haven't received an invitation, just call or email us to initiate.

### My Tax Return Start to Finish:

- 1. Prepare documents and information to send:
  - a. Client Checklist based on 2018 taxes
  - b. General Client checklists available: http://cresseyrice.com/tax-checklists/
- 2. Send documents and information securely:
  - a. Intuit Link (you login)
  - b. Safe Send portal drop box (no login)
  - c. Fax or Mail
- Receive confirmation CRTS received and estimated date we will be in touch with questions.
- 4. Questions/Answers until return is ready
- 5. Receive a review copy
- 6. Cressey calls to finalize the return, plan ahead, and accept tax prep payment (no additional charge for cc)
- 7. Receive taxes for electronic signing/sign in person
- 8. Receive receipt of electronic filing along with directions for checking on refund status/making payments.
